Facilities

Heritage Center is the home of the BECHS which houses the museum, gift shop, research center, administrative offices, meeting room, public art gallery, archives and collections storage. The Society moved into the Heritage Center in 1988 after being located at the R.D. Hubbard House for 50 years. The Heritage Center is open Tuesday – Saturday 10 a.m.– 4 p.m.

R.D. Hubbard House is owned by the City of Mankato and operated by the BECHS. The BECHS purchased the house from the Hubbard Family in 1938 and then sold it to the City of Mankato. The City maintains the grounds, utilities and assists with grants for restoration. The Hubbard House is open seasonally: May and September Saturday and Sunday from 1-4 p.m. and June-August Friday-Saturday 10 a.m.-4 p.m. and Sunday 1-4 p.m.

The Marian Anderson Art Gallery is owned by Meyer Financial and operated by the BECHS. In 2010, Marian Anderson generously transferred the business of selling her art to the BECHS. All profits from the sale of art benefits the organization today and in the future with 50% of the revenue being transferred to an endowment fund for future expansion.

TITLE: Members, Board of Trustees

ROLE: To serve as a voting member of the Board of Trustees for the Blue Earth County Historical Society, developing policies, procedures and regulations, monitoring financial performance and the organization's programs and services.

TERM: 3 years, beginning March 2011 and ending March 2014.
There is a term limit of two consecutive terms.

TIME EXPECTATIONS:

- Attend regularly scheduled monthly meetings of the Board of Trustees.
- Participate actively in one or more committees of the Board.
- Attend scheduled board retreats, planning meetings, workshops or other board development activities
- Attend, support and participate in special organization events.

OBLIGATIONS:

- Fully understand and support the mission of the organization.
- Actively set policy and ensure that the organization has adequate resources to carry out its mission
- Hire, supervise and evaluate the Executive Director.
- Make annual personal [and/or professional] financial commitment.
- Monitor the organizations' financial performance and legal responsibilities.
- Develop and monitor short and long-range planning and goals.
- Represent the organization to the public and private sector; serve as an advocate for the organization.
- Bring personal and/or professional expertise and that of others to support the mission of the organization.
- Be a BECHS Member in good standing.
